Payment Card Issuance Agreement (hereinafter referred to as the "Agreement")

I.

1. ČSOB shall give the Account Holder a payment card in accordance with data stipulated in Article II hereof after the terms and conditions stipulated herein have been fulfilled. ČSOB is entitled to provide a payment card at the Account Holder's request to person(s) authorised by him.
2. Both the Terms and Conditions for Payment Cards of ČSOB Clients as of July 1, 2011 (hereinafter referred to as the "Terms and Conditions"), Rules for Image Cards with Own Design as of May 1, 2007 (hereinafter referred to as the "Rules") and the ČSOB General Business Terms and Conditions as of April 1, 2011 (hereinafter referred to as the "GBTC") shall be a part hereof. Different provisions of the Agreement shall take precedence over the Terms and Conditions and the GBTC. The Account Holder declares that he agrees with the Terms and Conditions, the Rules and the GBTC, which he has been given and has made himself acquainted therewith and undertakes to adhere to them.
3. The Account Holder authorises a person who in accordance herewith will become a holder of an image card to dispose of funds deposited in his account via a payment card. The Account Holder is obliged to make acquainted the holder(s) of a payment card with the Terms and Conditions, the Rules and the GBTC.

4. ČSOB and the Account Holder have agreed that ČSOB will be entitled to collect fees from his account stipulated in Article II hereof in accordance with the ČSOB Price List as subsequently amended.
5. The Agreement has been made for an indefinite period of time and shall become valid and effective as of the date of signature by both contracting parties.
6. Both ČSOB and the Account Holder can terminate the Agreement any time by giving a written notice. If the Account Holder terminates the Agreement the notice period will be a month and will begin on the next day after the delivery of the notice of termination to ČSOB. If the Agreement is terminated by ČSOB the period of notice will be two months and will begin on the first day of the calendar month after the month in which the notice of termination is delivered to the Account Holder.
7. Should the Agreement be terminated by the Account Holder, he will be obliged to return to ČSOB the image card issued to his account stipulated in Article II hereof. Should the Account Holder not fulfil this duty on or before the first date of the period of notice at the latest, ČSOB will be entitled to block the image card.
8. Should the Agreement be terminated by ČSOB the Account Holder will be obliged to provide for the return of the payment within 14 days of receipt of the Withdrawal from the Agreement. Should the Account Holder not fulfil this duty ČSOB will be entitled to block the image card.
9. The design of the image card will be chosen from the ČSOB gallery or pictures or photographs delivered by the Account Holder or by the holder of the image card (hereinafter referred to as the "Photographs").
10. The Agreement has been executed in two copies of which each party shall receive one copy.
