1. Installation of SecureStore

1.1. Installation of the chip card reader and SecureStore application

SecureStore is available at www.csob.cz at **ČSOB InternetBanking 24** (ČSOB BusinessBanking 24) – **download software** under the **SecureStore card manager**. A detailed installation instruction is available in the **SecureStore Installation Manual**.

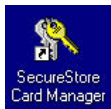


Notice: Use the installation package appropriate for the version of Windows operation system you use (this can be found out in the **System** folder located usually in the **Control Panels**). Installation packages are available for the following versions:


- 32bit – **securestore_X_xx_csob_x86.zip**,
- 64bit – **securestore_X_xx_csob_x64.zip**.

1.2. Verify the SecureStore operation

Start the application using the icon on the Desktop.



If the chip card data has been downloaded into the **SecureStore Card Manager** screen the installation has been correct. Now, you can close the application.

2. Google Chrome Settings

The initial browser settings are appropriate for both ČSOB InternetBanking 24 and ČSOB BusinessBanking 24. Therefore, there is no need to modify them.

3. First Login

Start the browser and enter <https://ib24.csob.cz> (ČSOB InternetBanking 24) or <https://bb24.csob.cz> (ČSOB BusinessBanking 24) and then click on **log-in** in the **Log-in with chip card** section.

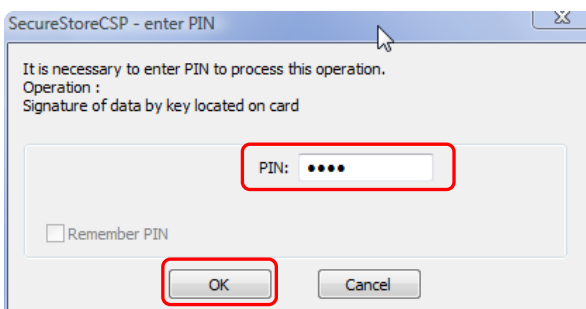

If the basic configuration of your PC does not comply with CSOB requirements a screen with the list of errors might appear. In such a case, follow the instructions displayed.

If the basic configuration is alright the following window will be displayed; tick **Always trust content from this publisher** in the window. Press **Run** to allow the initial download of the JAVA applet for communication with the chip card.




Enter you chip card PIN in the following window and log in to the service by pressing the **OK** button.



4. Testing the operation system, browser and other components

Start Google Chrome, enter <https://ib24.csob.cz> (ČSOB InternetBanking 24) or <https://bb24.csob.cz> (ČSOB BusinessBanking 24) and then click on **system test** in top right corner. Use the test to check that your computer is correctly set to run the service. The test requires JAVA applet installed (without it only a part of the test will run).



Result

The test will find out whether your computer meets the requirements for CSOB Internet banking for the following parameters:

1. **JavaScript** (if your browser allows its use including the settings).
2. **Java** (recommended for the use of the chip card: Java 1.6 or higher).
3. **Operation system** (recommended: Windows XP SP3, Windows Vista and Windows 7).
4. **Web browser** (recommended: Internet Explorer 7.0 or higher, Firefox 1.5 or higher and Opera 10).
5. **Monitor resolution** (recommended: 1024 x 768 points or higher).
6. **Cookies** (must be allowed).
7. **Opening of session** (must be allowed).
8. **ActiveX** (for electronic signature verification in Internet Explorer).
9. **Chip Card Manager** (SW suitable for chip card management must be installed).
10. **USB ports** (must be functional for chip card usage).
11. **Electronic signature** I want to test (you must insert the chip card into the reader).

Without the Java application some tests may be skipped ([download Java](#)).

When all the test stages have been completed the result will be displayed. If this meets the requirements you can return to the introductory page by pressing **end test >>** button and start using the service.

If any item of the result is incorrect please modify the relevant settings according to the recommendations displayed. The ActiveX is an exception as it cannot be performed correctly in Google Chrome.
