Dear Client,

At the end of the year the Bank must pay a fee to the Resolution Fund, which is calculated on the total deposits as at December 31. ČSOB will not charge clients who do not change their standard way, i.e. whose deposits on December 31 are not more than the amount they normally keep within our business relationship throughout the year, for this fee.

The mechanism of one decisive day may result in purposely transferred funds of short-term liquidity. Therefore, ČSOB reserves the right to charge this fee in certain cases.

The Bank has the right to charge a 0.15% fee on funds which on December 31 exceed:

- a) CZK 100 million and concurrently
- b) the average deposits calculated from positive balances on the last day of a particular month from January 1 to November 30 of a particular year.

The calculation includes the total client funds in current, savings, time deposit accounts and deposit bills (notes) in all currencies.

The Bank has the right to charge this fee once a year. The fee is payable no later than the second business day of March in the next year and is debited from the client's fee account. If the client does not have an account for paying fees, it is debited from the current account with the highest balance on the due date of the fee. The current CNB exchange rate on that day is used to convert foreign currencies into CZK and vice versa.
