■ Schneider Electric – smart energy solutions for a sustainable world

Schneider Electric is a global leader in energy efficiency and automation. The company helps businesses and households optimise energy consumption, reduce costs and protect the environment at the same time. Its innovative technologies enable smart management of buildings, industrial processes and renewable energy sources.

■ Linde – a pioneer in clean technologies

Linde is a major global player in industrial gases and innovative solutions for cleaner production. The company plays a key role in the transition to a low-carbon economy through technologies for CO₂ capture and utilisation, hydrogen production and support of renewable energy.

Who is the fund intended for?

The fund is designed for retail clients with basic investment knowledge who are aware of the risks associated with investing in conventional investment funds and their attitude to risk is **Very dynamic**. Which means that the client prefers the potential for return even at the cost of significant fluctuations in the value of the investment. He/she is aware that the value of the investment may be several years below the initial value and expects a return significantly higher than the return on regular bank deposits.

Summary Risk Indicator (SRI):

This is based on the legislation and allows comparison with other products. The indicator reflects the volatility of the fund value resulting from market developments.



Product score (PS):

Allows the comparison of the savings and investment products from the ČSOB/KBC Group in terms of risk. It takes into account amongst others the volatility of the investment.
